Held in conjunction with the Singapore Accountancy Convention 2014, the inaugural Singapore Accountancy Awards was organised to honour exemplary individuals and businesses in the local accountancy sector. The Awards also aims to promote good corporate practices, individual excellence and strengthen branding of the profession and industry.

The Singapore Accountancy Awards comprises two categories, the Business Excellence Awards and the Individual Excellence Awards. The Business Excellence Awards are made up of the Practice of the Year, Technical Excellence, Excellence in People

Development, and Excellence in Productivity & Innovation awards. The Individual Excellence Awards include the Accountant of the Year and Young Accountant of the Year awards.

The Singapore Accountancy Awards 2014 was supported by the Accounting and Corporate Regulatory Authority and the Singapore Accountancy Commission.
